

APPLICATION FOR MEMBERSHIP

To become a member of the **COOPÉRATIVE DE DÉVELOPPEMENT RÉGIONAL DU QUÉBEC** (hereafter referred to as “the CDRQ”), a cooperative, worker, or organization must subscribe to ten (10) common shares of ten dollars (\$10) each (for a total of \$100). In addition, they must agree to respect all the CDRQ’s rules and be admitted by the CDRQ’s board of directors.

Cooperative members, worker members, and support members must also pay an annual contribution, the amount of which is set by the CDRQ’s board of directors. The contribution is payable at the latest within thirty (30) days following receipt of the invoice from the CDRQ.

Cooperative member agreements: The members, the meeting of the members, the board of directors, and all other committees stemming from the cooperative agree to respect the CDRQ's mission, objectives, and cooperative by-laws. Furthermore, the members agree to respect the values, principles, and rules of cooperative action as defined in law:

Cooperative Values: The International Cooperative Alliance has defined **five core cooperative values** and four ethical values that members must agree to when starting or operating a cooperative. Members assume **personal and mutual responsibility** in a collectively owned enterprise where power is exercised according to **democratic** rules. Members are all **equal** and each has one vote. They are treated **equitably** in the operations of the cooperative and they work for the collective and general interest in a spirit of **solidarity**. The members of Quebec cooperatives and mutuals are committed to the ethical values of honesty, openness, social responsibility, and caring for others.

The Principles: **Seven main principles** guide cooperative life. **Membership is voluntary and open to all** without discrimination. **Each member exercises democratic power** to participate actively in decision-making. They contribute **economically** to the capital of the cooperative in an equitable manner and surpluses are allocated to development and to building up reserves to ensure the future of their cooperative. All agreements and relationships with other organizations must **maintain the autonomy and independence of the cooperative**. The cooperative has a **mission to offer education, training, and cooperative information** to its members and the community. By promoting **cooperation**, cooperatives are stronger and offer better services to their members. **The cooperative is committed to the community** and contributes to its sustainable development.

To become or remain a CDRQ member, a cooperative, worker, or support organization must:

- a) Subscribe to the minimum number of shares in accordance with the CDRQ's cooperative by-laws ;
- b) Be a member within the meaning of the *Cooperatives Act* and the CDRQ's cooperative by-laws ;
- c) Comply with the provisions of Article 51 of the Act, and
- d) Agree to respect the mission and rules of the cooperative.

*****The CDRQ reserves the right to exclude a member for failure to comply with its rules.**

Step II: Obligation of the person or organization

The person or organization agrees to :

- a. Pay for its member shares ;
- b. Pay the annual membership fee to the CDRQ.

3. In return, the CDRQ agrees to:

- a. Offer quality services to all its members ;
- b. Publicize all of its partnerships ;
- c. Ensure that cooperation remains an enriching experience.
